## Most Common Laboratory Test Tariffs for Private Hospitals

Private Health Services Regulatory Council (PHSRC) has received several complaints through different channels including direct communications from customers, community action groups, Consumer Affairs Authority and Presidential Secretariat regarding exorbitant charges imposed by Medical Laboratories of Private Hospitals and other Medical Laboratories.

After much deliberations including obtaining views and observations from different stakeholders and careful evaluation of the situation, PHSRC identified a maximum and a minimum tariff for 33 most common medical laboratory tests with the view of benefiting the public. (The tariffs for those 33 identified common tests are attached herewith as an Annex I). At its meeting held on 14/08/2015, PHSRC decided to request all Private Hospitals to comply with the following with regards to medical laboratory test tariffs.

PHSRC would like to request all private hospitals to adopt the identified maximum and minimum values for any given test from the list of 33 identified common laboratory tests until further notice. Council would appreciate further, if every hospital adopts the minimum value whereas no hospital is expected to exceed the maximum value for any given test. Every Private Hospital should display the test tariffs that will be charged as per the annex I to be easily viewed by the public. If unable or difficult to do so with print media, the hospital could comply by using the electronic media.

Your kind cooperation in this regard is greatly appreciated.
